Conference Digest 2020.

Finances: A healthy balance was reported, £5619.14 being held in HSBC, £11451.85 in CFB and £42.85 cash making a total of £17,113.85. We have received into CFB £1,200.80 from HMRC as gift Aid for 2018/19 with thanks to Ro for her work on this. We currently pay £6,888 per year for assessment and this we agreed at the last meeting to increase to £8,000 for the year starting 01/09/2021. A calculation of the assessment for the coming year was in excess of £13,000 which we could not afford. DG commented that we had met our obligation despite being a small congregation. We agreed to review our contribution at the end of this church year.

Property: Peter reported Handrails and ramps are now in place. One of the heaters in the Hall is not working correctly. BG to investigate. **(Action)** He is also working to provide an automated timer to be installed, so that heating would automatically come on for services etc. before we arrive.

Safeguarding: Mavis reported that all was in hand. Jenny and Mavis were awaiting arrangements for attending or online Advance module Training Course. Chris reported that his DBS had been renewed for a further 5 years.

Pastoral: Ernie is not so mobile. Val Trice is still recuperating in a nursing home. Peter and Beryl have Medical issues. We have 16 current Members. Margaret Crystal from former Rainham Methodist church stays in contact with our members as well. We bade a fond farewell at the virtual February Coffee Morning to Michael and Ro Read-Leah, as they have now moved out of the area. Robert asked if a rota could be arranged, of those willing to provide intercessions to be included in the weekly notices. Agreed. **Action Robert**

News from the Circuit: Derek was able to report that no-one is to be stationed for Sept 21 for the Chinese church and 2 other churches north of the river. Two candidates came for interviews, but declined our offers.

He also reported that an initiative to possibly fund the facility of showing the circuit services on screen in all our churches so that Congregations can share in the services provided. The Circuit is expecting churches to reopen in due course but the YouTube services will continue. The Methodist Conference in June 2020 was launching investigations into ways to help small churches cover the various administrative and other roles that the Church requires, by joining small churches together to ease the problem. Discussions are to take place at local level soon.
